## What you need to do for your application

### Before you start!

### Complete the application

The form is to be completed by the owner of the property on which the swimming pool or spa is located.



### Submit the application

Submit your application along with all supporting documentation and your registration fee of \$80.30.



### Confirmation

If your application is successful you will receive written confirmation within 10 working days.
