



MINUTES OF THE CONFIDENTIAL MEETING OF THE PORT PHILLIP CITY COUNCIL HELD 18 MAY 2022 IN ST KILDA TOWN HALL

17. CONFIDENTIAL BUSINESS

17.1 Interim Kerbside Waste Collection & Recycling Processing Arrangements

Councillor Clark declared a material conflict of interest to a direct association with the matter and left the meeting at 9.28pm and did not return to the meeting.

MOVED Crs Crawford/Copsey

That Council:

- 3.1 Notes that it is necessary for Council to enter into bridging arrangements for waste collection and recycling processing to ensure service continuity while full market processes are undertaken.
- 3.2 Award a contract for collection services to the value of \$9,169,165 excluding GST (\$10,086,082 including GST), for a contract term of 12 months commencing 1 July 2022 to 30 June 2023 with no extension option to Four Seasons Waste Pty Ltd. Collection services to be awarded are:
 - a) residential kerbside waste collection at a cost of \$3,244,119 excluding GST (\$3,568,531 including GST),
 - b) residential kerbside recycling collection at a cost of \$2,929,334 excluding GST (\$3,222,267 including GST),
 - c) hard waste booked collection & proactive dumped rubbish collection at a cost of \$1,480,335 excluding GST (\$1,628,368 including GST).
 - d) residential food and organics collection for existing services at a cost of \$127,711 excluding GST (\$140,482 including GST),
 - e) option for foreshore litter bin collection on peak days to be exercised by 1 September 2022 for a cost of \$46,323 excluding GST (\$50,955 including GST),
 - f) option for additional communal glass collection in accordance with draft *Waste Management Strategy 2022-25* to be exercised by 1 October 2022 at a cost of \$74,779 excluding GST (\$82,257 including GST),

- g) option for additional kerbside FOGO collection in accordance with draft *Waste Management Strategy 2022-25* to be exercised by 1 October 2022 at a cost of \$1,266,564 excluding GST (\$1,393,220 including GST).
- 3.3 Approve a two-year extension to the value of \$3,363,855 excluding GST (\$3,700,241 including GST), for the provision of Recycling Processing Services, Contract Number 413, to Cleanaway Pty Ltd.
- 3.4 Notes that the combined cost of these contracts of \$10,851,093 excluding GST (\$11,936,202 including GST) for 2022/23 will require an additional \$1,112,148 (inclusive of GST) allocated in the Draft Budget 2022/23 and that the options listed above in 3.2 f) and 3.2 g) will only be exercised if determined to offer best value for money following procurement of ongoing long-term collection services which is currently out to market.
- 3.5 Authorises the CEO to update this resolution to reflect decisions made by Council in items 3.2 and 3.4, to accurately publish this resolution in the minutes.
- 3.6 Authorise the CEO and Council Officers to share any necessary confidential information required to enter into contracts on Council's behalf in accordance with this resolution.
