Message from the CEO

Welcome to the October CEO Report, which includes an update on the priorities that Council has set for me.

Deliver the Council Plan

Overall project portfolio delivery status for August is 74 per cent on-track progressing as planned, 13 per cent at-risk, and 13 per cent off-track. This is slightly lower than last month, related to cost pressures and some delays.

As part of continual improvement, this report now contains updates on the status of many of our priority projects that are in the delivery phase, including the Early Education and Children's Centres Infrastructure Program, the South Melbourne Town Hall redevelopment, Eco Centre redevelopment, Gasworks Park Upgrade, Lagoon Reserve Upgrade, the Housing Strategy, and the Elwood Foreshore Facilities Development.

As mentioned below, with the new Council now elected, we have commenced work on development of their Council Plan and commenced community engagement to inform this.

Governance and Advocacy

Elections for the City of Port Phillip Council were held in October. In the lead up to this, the organisation was required to adhere to the Election Period Policy. This meant that no prohibited or inappropriate decisions could be made that could influence the election or unreasonably bind the incoming Council, while still ensuring that essential services were maintained for the community.

At the time of writing, the outcome of our election has been announced, Councillor Crawford has been appointed as Mayor and Council Mears as Deputy Mayor. The councillors have completed their first phase of induction and training and held their first ordinary meeting. Congratulations to all councillors on their election and thanks to our outgoing councillors for their service to Port Phillip over the last four years.

Community, Stakeholder, and Customer

For October, 94.3 per cent of community complaints and 88.1 per cent of community service requests were resolved within agreed timeframes. These results surpassed their 80 per cent targets and figures from the same time last year. These outcomes show our continuing commitment to our Customer Service and the dedication of our teams resolving these requests. We continue to focus on improvement in several areas including planning permits, parking permits, garden bed maintenance, and weeding.

In October we also held our Seniors Festival, with a record 43 community and Council-led events

on offer. This included 11 events hosted by the Port Phillip Library Service, which showcased the vibrancy of older residents and the importance of positive ageing in Port Phillip. Over 2,100 people participated in events held across the municipality, including live music performances, art, dance, and cultural celebrations.

We were also excited for St Kilda Festival to be awarded the Best Metro Festival at the Music Victoria Awards in October. This is a huge achievement, and I am very proud that the mammoth amount of work this team undertakes to put on this iconic Festival is being recognised.

In October we also hosted a new food and wine event, Spring Graze Southside, which featured an exciting array of unique local dining and drinking experiences at over 40 of our well-loved established venues and high-profile newcomers. With a focus on local and sustainable food and wine practices, program highlights include Melbourne Food & Wine Crawl and Bite Southside, a five-event series produced by Melbourne Food and Wine, and a broader program of independently produced events including dinners, tastings, tours, bespoke dishes and drinks menus, and other special events. This event was the first of its kind in the City and it was exciting to see it all come together.

Culture and capability

October staff turnover was 16.5 per cent. The higher-than-average turnover is attributable to recent Australian Government aged care reforms and the transition of some of our in-home services to other providers. We will continue to deliver community-based services. The voluntary turnover rate is 11.9 per cent.

This month we also continued our work on educating and supporting staff on Family and Domestic violence. We have recently released a specific policy to support staff experiencing Family Violence, as well as accompanying resources for our supporting employees and managers. As part of the lead up to the 16 days of activism, we also hosted Kristy McKellar OAM as a keynote speaker at an all-staff session creating awareness of prevention of family and domestic violence, which was an incredibly powerful event.

Solihull Parenting Group

Since 2020, we have facilitated the Solihull Parenting Group. The Solihull Approach is an evidence-based framework incorporating infant mental health. The program covers topics like having fun together, developmental needs, anger management, parenting styles, and sleep. Handouts and home activities each week reinforce the learning.

The Solihull Parenting Program, has generated valuable feedback from parents, revealing key themes that will inform program content to strengthen family dynamics and enrich the parenting experience.

The Family Support team will continue to deliver the Solihull Parenting group next year, in line with our commitments in the *Children's Services Policy: Every Child, Our Future.*

2024 Port Phillip Seniors Festival

The annual Port Phillip Seniors Festival 2024 was held from 1 to 14 October, with a record 43 community and Council-led events on offer. This included 11 events hosted by the Port Phillip Library Service, which showcased the vibrancy of older residents and the importance of positive ageing in Port Phillip.

Over 2,100 people participated in events held across the municipality, including live music performances, art, dance and cultural celebrations.

This year, the state government provided extra support to build a more inclusive and accessible festival, reaching a broader number of seniors using an intersectional approach. This approach increased the number of diverse events in the program and was well received by the community.

One such event was an afternoon held at the Victorian Pride Centre (VPC) where they hosted activities such as yoga, a bling-making workshop, oral history workshop, tour and an afternoon tea. At this event, the VPC had 30 people express interest to start a regular senior group for the LGBTIQA+ community.



Number of people actively sleeping rough (monthly data)



This measure replaces the direct hours of housing assistance measure. This is the first time this data has been reported monthly – data is provided by Launch Housing. During October, there were 31 rough sleepers in our community. Council continues to support a coordinated response to rough sleeping. This involves a range of Council services and partnering with community organisations and Police.

Number of older local persons housed (cumulative year to date)



For October 2024, the number of older persons housed was 11 against a monthly target of five bringing the year-to-date figure to 29. This is an improvement compared to the same time last year where 22 older persons were housed. Several housing vacancies were available through Council's sponsorship housing agreement with Housing Victoria. Council's Sponsorship Housing List is open for people aged 55+.

Liveable Port Phillip

A City that is a place to live, where our community has access to high quality public spaces, development and growth are well-managed, and it is safer and easy to connect and travel within.

Walk and Wheel active travel program

Council's Walk and Wheel active travel program encourages young people to walk, ride, scoot, skate, or use public transport on their way to school.

In 2024, six schools participated in the program, which kicked off in early October with a Smoothie Bike session for students at St Kilda Primary School. This was followed by a visit from Dr. Cranky, the bike doctor, whose primary school-based bike recycling program ensures that all kids have access to roadworthy bikes. Donated bikes are refurbished and given to students in need at participating schools, with parent volunteers assisting in repairs during school Bicycle Hospitals and Bike Checks. The other five schools will host month-long programs throughout October and November.

Ride2Work Day

Ride2Work Day was celebrated on Wednesday 16 October, highlighting the joy of commuting by bike and encouraging everyone to get active on their way to work.

Our public event at South Melbourne Market attracted around 100 attendees. The festivities included anti-theft bike engraving by Victoria Police, bike tune-ups by Back2Bikes, breakfast and coffee provided by market traders, and live entertainment.

Additionally, Council's staff event also included bike tune-ups, breakfast treats, and the popular smoothie bike, with employees cycling in from as far as Brighton in the south and Reservoir in the north to make it to work on time.



Number of fines issued related to animal management




For October 2024, there were 67 fines issued related to animal management. This is an increase of 49 fines compared to last month.

Of the 47 animals collected from 1 July 2024 to 31 October 2024, 23 animals (48.9 per cent) were reclaimed by their owners. Out of the remaining 24 animals, 7 animals were rehomed (29 per cent). A further 7 animals (29 per cent) were being assessed at the time this report was generated. All avenues are explored to ensure animals find new homes. Twelve out of the 47 animals collected were surrendered by their owners (25 per cent) and 10 of the remaining animals were euthanised.

Council received 11 sealed local road requests in October 2024 which is within the monthly threshold target of not more than 11 requests per month. The requests were related to damaged kerb and channel and laneways. Year-to-date there have been 46 requests against a year-to-date target of 44 requests

Sustainable Port Phillip

A sustainable future, where our environmentally aware and active community benefits from living in a bayside City that is greener, cooler, cleaner, and climate resilient.

Port Phillip Environmental Leaders course

The second Port Phillip Environmental Leaders course for 2024 has just wrapped up, with 12 graduates completing the course. Since it's conception in 2018, the course has accepted 266 community members to take part in a 10-week program.

The primary aim of the program has been to connect our community members to generate thousands of ideas and actions that have resulted in all manner of community projects. The course could be more aptly described as an inner journey in community building. This unique program has stood the test of time and continues to evolve to support the growing needs of our community. In addition to the course, a leadership network has been established in partnership with other local governments and community organisations.

Safety and Amenity update


During October, 14 joint patrols were conducted with police in hotspot areas of Fitzroy, Acland. Carlisle Street and Clarendon Street. Twenty-nine shopping trolleys were removed from Fitzroy Street alone during the month and a total of 82 separate clean-up activities undertaken in those streets. In addition to the cleans ups and patrols, Council officers also offer support and assistance to those sleeping rough, making offers to 10 people during the month for referrals to support services. 

Kerbside bin collection requests (per 1,000 households)



Kerbside bin collection requests for October 2024 were 18.77 requests against a monthly threshold of 25 per requests 1,000 households. The number of requests is significantly down from last year following issues after the contract transition to the new provider.

Percentage kerbside collection waste diverted from landfill



During October 2024, 40.3 per cent of kerbside collection waste was diverted from landfill which meets the 40 per cent target and is a slight improvement compared to the same time last year at 38 per cent. The uplift trend is attributable to the roll-out of FOGO to muti-unit dwellings.

Kerbside collection bins missed (per 10,000 scheduled kerbside bin lifts)



Kerbside missed bins was 8.63 collections per 10,000 bins in October 2024 against a target of less than five. This is an improvement on the same time last year at 20.71 missed collections per 10,000 bins. The improvement trend is continuing in line with previous month performance.

Percentage of investment in fossil-free institutions



Investment in fossil-free investment for October was 70 per cent, which is above a 60 per cent target. The percentage of investment in fossil-free institutions has been relatively stable over the past year and consistently above the target.

Feminine Play Exhibition

Feminine Play is a curated games exhibition presented at Carlisle St. Art Space during Melbourne International Games Week 2024.

Curated by feminine games researcher Stephanie Harkin (RMIT), with partners and collaborators from RMIT, Monash University, The University of Melbourne, NFSA and ACMI; this interactive public exhibition draws on Harkin's research on feminine games and play cultures.

Feminine play has been overshadowed by traditional thinking that pairs games with boyhood, competition, and violence. The exhibition encourages a reimagining of games and play that accounts for experiences and perspectives that often go unnoticed.

IGEA's Australia Plays 2023 Report found that Australians play games for improved wellbeing and a sense of community, and yet a decline in women players aged betweenB14–24 was reported. There is a need to address the cultural forces that disenfranchise girls from games, as well as represent the various identities engaging with complex and radical interpretations of femininity.

By curating an assortment of thoughtful games this exhibition invites visitors into a meaningful dialogue around gender, culture, and games. The project offers intersectional perspectives on femininity in games from across Australia, New Zealand, and the Asia Pacific.

The exhibition opening included an entertaining panel conversation hosted by Stephanie Harkins, with game creators and exhibitors Helen Kwok, Arch Rebels and Ruby Quail. The engaging and insightful discussion explored the experience of femininity, feminine roles, indie and alternative games spaces, and women in the mainstream games industry.



Visits to South Melbourne Market



In October 130 staff attended the positive psychology session and a wellbeing booth was held at an all-staff session to gain additional feedback and promote wellbeing resources to staff.



Governance Update

Elections for the City of Port Phillip Council were held in October. In the lead up to this, the organisation was required to adhere to the Election Period Policy, commonly referred to as caretaker. This meant that no prohibited or inappropriate decisions could be made that could influence the election or unreasonably bind the incoming Council, while still ensuring that essential services were maintained for the community.

A high level of compliance was achieved, with officers from across the organisation participating in information sessions to ensure they were aware of their responsibilities.

Percentage of community complaints resolved within agreed timeframes





Percentage of Councillor attendance at council meetings




For October, there was one Council meeting on the 16th of the month with 100 per cent attendance which exceeds the 80 per cent target.

Percentage of community requests resolved within agreed timeframes





Percentage of Council decisions made at meetings closed to the public




A total of 4 decisions were made at one Council meeting held during October 2024. None of these decisions were made in a meeting closed to the public.

Percentage of occupational health and safety incidents reported within 24 hours (cumulative)




In October, the percentage of occupational health and safety incidents reporting within 24 hours was 86.3 per cent which is above 80 cent target.
