### Restrictions

- **No amplified music** or potentially dangerous activities are permitted.
- Do not busk outside ATMs and your busking performance must not impact on businesses or the public.
- Busking is not permitted within the South Melbourne Market.
- Additional permits will be required to busk at the St Kilda Esplanade Market and the St Kilda Festival.
- Busking times are 9 am to 9 pm and buskers must not impact businesses or pedestrians.

If an event organiser is engaging any third party providers for services (such as the hire of equipment, provision of catering, etc.) they must provide Council with a Certificate of Currency from each provider.
